# 2. CONFIRM THE PREVIOUS COUNCIL MINUTES.

Members confirmed the 13<sup>th</sup> July 2015 minutes as a true record and signed by the Chairman.

# 3. MATTERS ARISING FROM THE MINUTES.

The Clerk reported that Councillor Kate Edge is researching the ownership issues regarding the Cyffylliog Church Cemetery and will report back at the next Council meeting.

## 5. PLANNING APPLICATIONS.

- A. Change of use of agricultural building into motor vehicle and machinery workshop at Ty Brith Farm, Bontuchel. The Clerk reported that Mr Emrys Edwards (previous owner of Ty Brith Farmhouse) is opposing the application. The Members resolved to raise no objections to the planning application.
- B. Erection of a single storey extension to Seler, Cuffylliog no objections.
- C. Upgrade of existing 11kv overhead line on land between Ty Brith and Cae'r Hafod Isa, Bontuchel no objections.
- D. Lawful development certificate for existing use of land for the sitting of a caravan on land at Gelli Farm, Bontuchel. Members resolved on the following observations:-
- 1. The land is not on Gelli Farm land.
- 2. There is currently an enforcement order in place on the caravan.
- 3. The caravan is an eyesore.
- 4. The parking bay designated for the use of the "Lady Bagot's Drive" is used by the occupiers and visitors to the caravan.
- E. Installation of 2 wind turbines (hub height 24.8m, ground to blade tip height 36.6m) associated equipment housing and access tracks on land at Foel Uchaf, Cyffylliog. Councillor Gethin Jones took no part in the planning application under consideration and vacated the meeting room. The Members raised no objections to the planning application.

#### 6. CORRESPONDENCE.

- A. the Clerk received a request from a resident of the community:-
- 1. Advance purchase of a plot at the new Cemetery in Cyffylliog. Members resolved that the original rules of the Community Council not to sell advance plots in the Cemetery should remain.
- 2. There is no mobile phone coverage in the community. The members resolved for the Clerk to make enquiries if a mobile phone mast can be provided for the Community.
- B. the Highways Department of Denbighshire County Council is seeking the Community Council's list of priority roads for the Highway Improvement Works 2016/17 list. The Members resolved on the following priority roads:-
- 1. Cae'r Hafod Isa, Bontuchel to Hiraethog Junction.
- 2. Highway via Plas Trefor and Ffynnon Ddu in Cyffylliog.
- 3. Bontuchel Village via Wern Shade.
